# CEO, Capital Sisters International: Raising Investment Capital for Micro Loans to Women in Developing Countries Since 1998

Patricia has managed International Affairs and Microfinance initiatives for the U.S Congress, the State Department, Peace Corps, and the non-profit sector for decades - living, working, and traveling in more than 60 countries to evaluate international programs, raise funds for economic development, and promote financial inclusion for women in the world's poorest communities by pioneering Gender Lens Investing.

### Founding CEO, Capital Sisters International (1998 to the present)

Patricia established Capital Sisters International, a non-profit social enterprise, to provide grants and loans to Microfinance Institutions that make micro loans to women's enterprises in developing countries. In 2011, after piloting the world's first *Person-To-Person Lending Model* with micro loan recipients in 25 countries, she launched the world's first *Women's Bond to* finance the micro businesses with investment capital enabling the public to invest with purpose. These \$1,000 zero-interest notes (called Sister Bonds®) are sold to socially responsible investors with terms of one to five years. Bond proceeds have financed \$8 million in micro loans for women in Guatemala, Afghanistan, and the Philippines to date. Using a combination of grants and investment capital, Capital Sisters has now raised more than \$14 million dollars to finance 140,000 women's micro loans in the developing world. She was also instrumental in launching the micro insurance industry, bringing commercial firms into the movement.

# Microfinance and Gender Advisor, U.S. State Department for the Asia Pacific Economic Cooperation (APEC) Forum (2002-2011)

Patricia led U.S. delegations at high-level meetings with representatives of 21 APEC countries to promote financial inclusion and more enabling policies for women's businesses in the developing world.

### Microfinance and Gender Advisor to the U.S. State Department (2004-2011)

Assisted the State Department and host governments in designing and promoting microfinance programs and projects in the 21 APEC member countries; recruited and led the U.S. delegation of women leaders from business, academic, NGO, and policy sectors; and helped draft the annual recommendations to Ministers and Heads of State.

### Manager, Microenterprise and Gender Portfolios, US State Department (2001-2003)

Recruited by the State Department's APEC Office after 9/11: responsible for analysis and promotion of Microenterprise, Gender, and Financial Inclusion initiatives; represented the US at dozens of conferences for the 21 countries; led the US delegation of the Women Leaders Network; successfully lobbied to add Microenterprises to the Small and Medium Enterprises Working Group – which still meets annually.

### Evaluator, U.S. Congress, Government Accountability Office (GAO) – (1982-2002)

Patricia managed evaluations around the world to support Congressional Committees for 20 years:

## Issue Area Manager/European Office, Frankfurt Germany (1987-1993)

Managed teams evaluating US development assistance and international programs in Europe, the Middle East, and Africa; responsible for the East European and Soviet Portfolio after the fall of the Berlin Wall, including economic and structural reforms and nuclear power plant safety (reports led to the adoption of the world's first International Nuclear Safety Convention).

Led international evaluations of IMF/World Bank/USAID projects, hazardous waste cleanup at DOD facilities, maternal and child health, and other domestic and international issues; responsibilities included supervising regional audit teams, analysis, and recommendations to Congress.

### Co-Founder and CEO, Microenterprise Program, International Alliance for Women (1999-2010)

Established, managed, and raised funding for a Microenterprise Program with a global group of professional, executive, and entrepreneurial women's networks for a decade - raising awareness and funding for tens of thousands of women's micro loans in Africa, Asia, and Latin America.

Helped launch the Micro Insurance industry by lobbying commercial insurance leaders, including AIG Insurance, to develop products appropriate to the world's poorest communities.

Helped established Colorado Microcredit in 1997 to make \$500-\$5,000 loans to "un-bankable" low-income entrepreneurs in inner city Denver. Established a program evaluation function in the City Manager's Office; responsible for evaluating municipal programs to make them more efficient and cost effective.

Among the first seven women to work in an underground mine in Colorado (to earn tuition for graduate school): operated heavy equipment 2,000 feet below the surface and invented a more efficient device for the "shotcrete" rig (received company Innovation Award for efficiency and safety).
